### 1. Rights of Public Entity

NamWater reserves the right:

## **9. Opening of Quotations**

Quotations will be opened internally by NamWater immediately after the closing time referred to in instruction 8 above. A record of the Quotation Opening stating the name of the bidders, the amount quoted, and the presence or absence of a Bid Securing Declaration, will be posted on the website of NamWater and available to any bidder on request within three working days of the Opening.

## **10. Evaluation of Quotations**

NamWater shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of price or ownership cost, subject to Margin of Preference where applicable, to determine the lowest evaluated quotation.

## **11. Technical Compliance**

Bidders shall submit along with their quotations documents, catalogues and any other literature to substantiate compliance with the required specifications and to qualify deviations if any with respect to Public Entity's requirements.

## **SECTION IV: SPECIFICATIONS AND PERFORMANCE REQUIREMENTS**

### **1. General**

This bid is for the supply and delivery of air release valves for Langer Heinrich Uranium Mine pipeline in the Business Unit Coastal of NamWater. The pipeline is a 300NB DCI.

These specifications are a supplement to the relevant **SANS** specifications (unless stated otherwise) and will in no way relieve the supplier of the requirements of the relevant specifications.

For coating purposes, “internally” shall refer to surfaces contacting the pumping medium, and “externally” shall refer to surfaces not contacting the pumping medium.

All air valves shall for triple action air release.

Where “superior stainless steel” or “superior grade stainless steel” is specified, the term “superior” refers to corrosion resistance.

Bidders shall complete a Technical Compliance Sheet for every item offered. Supporting literature for every Model of items offered shall therefore also be attached.

Bidders are encouraged to submit primary and alternative offers provided that the offers are in full compliance with the technical specifications, and that supporting literature verifying compliance is submitted.

Bidders are requested not to submit offers for items not complying with the technical specifications or where supporting literature cannot be supplied to verify compliance, specifically with regards to coating requirements, drinking water certifications / approvals, and construction / operational specifications.

#### **TECHNICAL COMPLIANCE AND SUPPORTING LITERATURE**

Bidders are required to complete a *Technical Compliance Sheet* for every range of items offered. Bidders shall refer to their attached supporting literature in their bid document to substantiate compliance.

**Offers will be disqualified if the Technical Compliance Sheet is incomplete and if required supporting literature is not submitted.**

Only original supporting literature/documentation will be accepted. Supporting literature supplied on a compact disk or flash drive in electronic format (PDF only) will be acceptable.

**AFTER SALES SERVICES**

An authorised service agent capable of servicing the offered items must be located in Namibia.

**TRANSPORT, STORAGE & HANDLING**

The items shall be adequately packaged and supported during transit to ensure the items are not subjected to undue damages or stress.

**1. DOUBLE ORIFICE AIR RELIEF VALVES**

**Operating Requirements**

The double orifice, triple action air valves are designed to allow air to rapidly either escape or enter the pipe system when filling or draining, as well as for automatic discharge of accumulated air during normal working conditions.

The design allows air to rush out of the system at great speed without forcing the float upwards and closing it prematurely. This makes sure that the valve closes only after all air has left the system and water has entered the chamber.

Flange materials shall be epoxy coated and all other components shall be made of approved polymer material or stainless steel to reduce corrosion risk even further.

The valves shall be installed as triple action air release valves for potable water applications.

**Air Valves for this bid:**

1. All items must be pressure rated at 40 bar.
2. The ambient temperature range: -10°C to 70°C.

The triple action air valves shall be threaded end connection type, DN50.

The valve air discharge and intake, pressure to flow graphs shall be included in the bid document.

The DN50 valves will be screwed in DN50 ball valves.

The complete product shall be approved for drinking water.

**Construction & Operational Requirements:**

All iron parts with contact to the water shall be coated with drinking water approved, fusion bonded epoxy.

The valves shall be able to open and close satisfactorily under a flow rate of 0-600m<sup>3</sup>/h at a maximum pressure as specified.
