1. Rights of Public Entity

NamWater reserves the right:

2. Preparation of Bids

You are requested to quote for the items mentioned in Section III by completing, signing and returning:

GENERAL DESCRIPTION AND BACKGROUND

This tender calls for the Supply and Delivery of Hot Dipped Galvanized 600NB distance piece with 600NB angle Tee and crotch plates for the Swakopmund-Rossing Booster 2 outlet. This specification covers the design, manufacture and supply of Hot Dipped Galvanized pipes. This specification is a supplement to the relevant SANS specifications and will in no way relieve the bidders of the requirements of the relevant SANS specifications.

STEEL PIPE DESIGN

The distance piece flanges shall conform to SANS 1123/2500/3.

Unless otherwise specified distance piece shall be rated S.A.B.S / SANS 719 Grade B.

The coating shall be Hot Dip Galvanized to S.A.B.S ISO 1461:1999.

The crotches shall be 30mm thick as per drawing

Note: The average galvanizing layer thickness shall not be less than 150 micron and the minimum thickness at any spot less than 100 micron.

The wall thickness of the distance piece is 6mm as indicated in this document is a minimum thickness.

PRESSURE TESTING

The distance piece shall be guaranteed for a test pressure of 1.5x rated pressure.

A guarantee pressure certificate shall be supplied with the items. Delivery will only be considered complete when all items and test certificates have been delivered.

TRANSPORTATION

Note: The distance piece shall at all times be transported and handled in such a manner as to guard against circumferential and radial distortion or damage. The supplier should ensure that during loading, transportation and delivery of the distance piece it is not distorted in any way, more specifically the circular profile structure of two plain ends.
